# **PAM BONDI**

U.S. Attorney General



Pam Bondi, a native of Tampa, Florida, serves as Chair of the America First Policy Institute's Center for Litigation and Co-Chair of the Center for Law and Justice. A trailblazer with more than 18 years as a prosecutor, she became Florida's 37th and first female Attorney General, tackling issues like Florida's reputation as the "pill mill capital" by successfully advancing reforms to shut down unscrupulous doctors and clinics. In 2017, Bondi also served on then-President Donald Trump's Opioid and Drug Abuse Commission, working on drug prevention, interdiction, and treatment efforts. A strong advocate for the First Step Act, which was signed into law in 2018, she championed reforms to help formerly incarcerated individuals reintegrate into society and reduce recidivism. With a steadfast commitment to public safety,

justice, and second chances, Bondi is well-prepared to serve as America's next U.S. Attorney General.

#### Advocate for Law Enforcement

Fighting alongside police departments, sheriffs, and other law enforcement agencies to tackle issues such as <u>human trafficking, opioid abuse, and</u> <u>organized crime</u>.

Supports initiatives to provide officers with additional training and resources to combat emerging threats, such as synthetic drugs and cybercrime.

Championing measures to protect first responders, including efforts to strengthen penalties for crimes against law enforcement with <u>support and</u> <u>recognition</u> from law enforcement organizations across the state.

#### **Opioid Epidemic Litigation**

Leading efforts to <u>address the opioid crisis</u> in Florida, including lawsuits against major pharmaceutical companies and distributors accused of contributing to the epidemic. These efforts sought accountability and resources to combat opioid addiction.

### **OPPOSES**

#### Human Trafficking

Fighting to <u>combat human trafficking</u>, advocate for stronger state laws, and increase public awareness. She also worked with law enforcement to enhance efforts to identify and support trafficking victims. Florida became a leader in anti-trafficking efforts, and her initiatives were widely supported across political and social spectrums.

#### Pill Mills & Prescription Drug Abuse Opposes <u>Florida's notorious "pill mills" clinics</u> that dispensed large quantities of prescription opioids with little or no medical oversight.

Working to strengthen state regulations, shut down rogue clinics, and hold unscrupulous doctors and operators accountable. She has helped reduce the number of pill mills and the availability of prescription opioids in Florida, contributing to a decline in prescription drug abuse.

**Consumer Protection Cases** Securing <u>financial relief for Floridians</u> <u>through major settlements</u>, including cases against mortgage servicers during the foreclosure crisis and lawsuits targeting fraudulent business practices.

#### **Fighting for Election Integrity**

Safeguarded fundamental rights in the <u>Coach Kennedy case</u>, challenging the <u>weaponization of government</u> for political gain.

#### **Defending First Amendment Rights**

<u>Condemned</u> the ongoing investigation targeting New York City Fire Department members for exercising their First Amendment rights through a demand letter directly to former New York City Fire Commissioner Laura Kavanagh.

#### Honoring Law Enforcement

Recognized the sacrifices of law enforcement officers during National Police Week to <u>highlight their</u> bravery and dedication.

#### **Protecting Supreme Court Justices**

Condemned Senator Chuck Schumer's (D-NY) remarks threatening conservative justices, standing against threats to the judiciary's safety and integrity.

#### **Opposing Unconstitutional Vaccine Mandates**

Led efforts to <u>protect citizens</u> from sweeping and unconstitutional vaccine mandates targeting private businesses, workers, and families.
